PROFESSIONAL PROFILE

Prof. Kariuki Muigua Ph.D; SC; FCIArb; OGW; C. Arb is a distinguished law scholar, Environmental Consultant, an accomplished mediator and a Chartered arbitrator. He is a holder of a Ph. D in law from the University of Nairobi and with widespread training and experience in both international and national commercial arbitration and mediation.

He is a Professor of Environmental Law and Conflict Management at the University of Nairobi Faculty of Law and the Centre for Advanced Studies in Environmental Law and Policy (CASELAP). He also teaches at the Wangari Maathai Institute for Peace and Environmental Studies.

He is also an Adjunct Professor at Kenya Methodist University School of Law.

He is a member of the Permanent Court of Arbitration at The Hague representing the Republic of Kenya. He was appointed as a member of the Protem Committee for the Asian International Arbitration Centre (Malaysia) (AIAC) Court of Arbitration.

He was appointed as a member of the inaugural Asian International Arbitration Centre (AIAC) Court of Arbitration as well as a member to the Asia Pacific International Arbitration Chamber.

He is recognised nationally and globally, with the *Chambers and Partners* rating him as one of the best dispute resolvers in the country. Chambers and Partners Global Guide 2024 ranked him in Band 1 of Dispute Resolution (Arbitrators), the ranking which recognizes the Top 6 Arbitrators in Kenya noting that he is “highly recommended as a leading lawyer”.

He has been described as ‘*a highly respected arbitrator and mediator with a sterling background in commercial and constitutional cases, as well as matters relating to the environment and natural resources*’.¹ This was further affirmed in recent rankings where Chambers and Partners stated as follows: “Kariuki Muigua of Kariuki Muigua & Co is held in high regard by market commentators for his role in the Kenyan arbitration sphere. He possesses stellar experience in commercial and constitutional disputes, as well as environmental matters and those relating to the extractive industries. He became the first winner of the Inaugural CIArb (Kenya Branch) ADR Lifetime Achievement Award 2021. He was also awarded the ADR Publication of the Year 2021 by the CIArb (Kenya Branch) for his numerous Arbitration and ADR publications which have over the time become the official reference texts and practice guides across Africa and beyond. This was a fitting and timely recognition of his research, scholarship and publishing efforts in the area of Alternative Dispute Resolution (ADR) as

an Author, Editor, Researcher, Scholar, Tutor, Assessor, Publisher and Peer-Reviewer. It is a recognition of the efforts he has made in the last 20 years in building a body of homegrown literature and content on ADR for use by practitioner and students.

He was the winner of the African Arbitrator of the Year 2022 award at the 3rd African Arbitration Awards held at Kigali Rwanda beating other competitors from Egypt, Mauritius, Ethiopia, Nigeria and Kenya. The African Arbitrator of the Year award is the highest and most prestigious ADR and Arbitration Award in Africa.

He was also awarded the ADR Practitioner of the Year Award 2022 at the AfAA Awards. The award which was presented by the African Arbitration Association is awarded to the Arbitrator/ADR practitioner who is adjudged to have made outstanding achievements in, or contribution to, the development of Arbitration/ADR in Africa.

He was recognized and awarded for his role as the Chartered Institute of Arbitrators (CIArb) Africa Trustee from 2019 to 2022 by CIArb Kenya Branch at the CIArb Kenya Branch ADR Excellence Awards 2022.

His book, *Settling Disputes through Arbitration in Kenya, 4th Edition*; Glenwood publishers 2022, was awarded the Publication of the Year Award 2022 by CIArb Kenya Branch at the CIArb Kenya Branch ADR Excellence Awards 2022.

He was awarded for his distinguished service to the Law Society of Kenya at the Law Society of Kenya Annual Awards 2023. He was also awarded the Outstanding Mentor Award by his mentees in recognition and appreciation of his selfless mentorship and support.

He was a member of the National Environment Tribunal which was awarded as the best performing Tribunal in Kenya for handling the most cases. He was among members of the Tribunal who were feted during the celebrations which were presided over by Environment and Forestry CS Kariako Tobiko and Deputy Chief Justice of Kenya Lady Justice Philomena Mbete Mwilu. The National Environment Tribunal was ranked the best in the caseload category in an evaluation exercise covering 2019 and 2020.

He is Kenya's foremost Environmental Law Scholar, Sustainable Development Advocate and Conflict Management Expert. Prof. Muigua SC is a leading Alternative Dispute Resolution (ADR) practitioner in Kenya, Africa and the world at large. He is a renowned arbitrator and has been appointed by the Chartered Institute
